

**RESOLUTION NO. 675 -2016, AUTHORIZING USE OF
MONTAUK COUNTY PARK BY NEO-POLITICAL COWGIRLS
FOR ITS ANDROMEDA DANCE THEATER PERFORMANCE
FUNDRAISER**

WHEREAS, Neo-Political Cowgirls is a 501(c)(3) nonprofit organization having its principle place of business at 236 Old Stone Highway, East Hampton, New York 11937; and

WHEREAS, Neo-Political Cowgirls would like to use Montauk County Park in the Town of East Hampton for the purpose of hosting its Andromeda Dance Theater Performance Fundraiser; and

WHEREAS, the Andromeda Dance Theater Performance Fundraiser is scheduled to be held on Thursday, August 25, 2016 through Sunday, August 28, 2016 from 6:00 pm – 9:00 pm; and

WHEREAS, a Certificate of Insurance with accompanying declaration page naming the County of Suffolk as an additional insured will be provided by Neo-Political Cowgirls; now, therefore be it

1st **RESOLVED**, that the use of Montauk County Park by Neo-Political Cowgirls for the purpose of hosting a fundraiser on Thursday, August 25, 2016 through Sunday August 28, 2016 from 6:00 pm – 9:00 pm, is hereby approved pursuant to Section 215(1) of the NEW YORK STATE COUNTY LAW, subject to the receipt of a Certificate of Insurance with accompanying declaration page by the County of Suffolk from Neo-Political Cowgirls, and the payment of the Six Hundred Dollars (\$600) event fee, and subject to such additional terms and conditions as may be required by the Risk Management and Benefits Division in the County Department of Law; and be it further

2nd **RESOLVED**, that before this event shall be permitted to occur, Neo-Political Cowgirls must apply for and obtain a permit from the Commissioner of the Department of Parks, Recreation, and Conservation as required by Section 378-7(B) of the Suffolk County Code; and be it further

3rd **RESOLVED**, that the Commissioner of the Suffolk County Department of Parks, Recreation and Conservation is hereby authorized, empowered and directed, pursuant to Section 28-4(A) of the SUFFOLK COUNTY CHARTER, to take such measures as shall be necessary and appropriate to facilitate the hosting of the fundraiser at Montauk County Park by Neo-Political Cowgirls; and be it further

4th **RESOLVED**, that Neo-Political Cowgirls shall also provide an entertainment promoter certificate to Suffolk County if it wishes to allow vendors at the event to sell tangible personal property other than food or drink and require these vendors to display such certificate in order to comply with the provisions of the NEW YORK TAX LAW; and be it further

5th **RESOLVED**, that this Legislature, being the lead agency under the State Environmental Quality Review Act ("SEQRA"), New York Environmental Conservation Law, Article 8, hereby finds and determines that this resolution constitutes a Type II action, pursuant

to Volume 6 of New York Code of Rules and Regulations ("NYCRR") § 617.5 (C)(15), (20) and (27), in that the resolution concerns minor temporary uses of land having negligible or no permanent impact on the environment, routine, or continuing agency administration and management, not including new programs or major reordering of priorities, and adoption of a local legislative decision in connection with the same, and since this is a Type II action, the County Legislature has no further responsibilities under SEQRA.
