RESOLUTION NO. 734 -2016, ACCEPTING AND APPROPRIATING 100% GRANT FUNDS FROM NEW YORK STATE DEPARTMENT OF HEALTH IN THE AMOUNT OF \$26,690 FOR THE TOBACCO ENFORCEMENT PROGRAM-ATUPA ADMINISTERED BY THE SUFFOLK COUNTY DEPARTMENT OF HEALTH SERVICES, DIVISION OF PREVENTIVE MEDICINE FOR A COST OF LIVING ADJUSTMENT (COLA)

WHEREAS, the New York State Department of Health has awarded Suffolk County State grant funds under the Tobacco Enforcement Program - ATUPA to be implemented by the Suffolk County Department of Health Services; and

WHEREAS, this grant has a start date of 4/1/2016 and ends on 3/31/2017 in which the County will receive 100% grant funding in the amount of \$26,690 for the Tobacco Enforcement Program - ATUPA COLA; and

WHEREAS, said funds have not been included in the 2016 Operating Budget; now, therefore be it
