Dear Presiding Officer Lindsay and Members of the Suffolk County Legislature:

RESOLUTION NO. 421-2011 AMENDING THE PROPOSED 2012-2014 CAPITAL PROGRAM AND THE PROPOSED 2012 CAPITAL BUDGET.

I am returning Resolution 421-2011 vetoed in its entirety.

This budget amendment creates a new \$2 million project for safety improvements to CR 16, Smithtown Boulevard at Gilbert Avenue/Sheppard Lane, Town of Smithtown. The initial study is being completed under Capital Project 3301 – Safety Improvements at Various Intersections. The Department of Public Works is already working towards these safety improvements, it is not appropriate to create an entirely new, unnecessary project, at this time.

In this fiscal climate, we cannot fund all of our needs at the same time. Prioritizing is essential; adding \$2 million for this purpose at this time is not necessary.

I urge you once again to sustain my veto.
