**PROCEDURAL RESOLUTION NO. 22 -2014, DIRECTING THE  
CLERK OF THE LEGISLATURE TO PROVIDE NOTICE OF  
PUBLIC HEARINGS TO INTERESTED PERSONS**

**WHEREAS**, notice of a legislative public hearing is advertised in the County's official designated newspapers and posted on the Legislature's website; and

**WHEREAS**, this Legislature wishes to take further action to publicize its public hearings and to invite citizen participation; now, therefore be it

**1st RESOLVED**, that the Clerk of the Suffolk County Legislature is hereby authorized, empowered and directed to establish a list of persons who wish to obtain notice of public hearings conducted by the Legislature and to send notice to these persons by electronic mail as these public hearings are scheduled; and be it further

**2nd RESOLVED**, that all persons who contact the Clerk's Office and request notice of public hearings shall be placed on the Clerk's list and shall receive email notice as required herein.
