Chairman D'Amaro and Members of the Budget & Finance Committee,

I am hoping and asking for your support at the upcoming committee meeting for IR1819-14, Creating a Taxpayer Protection and Notification Program.

This proposal was vetted and approved by the County Treasurer.

We have all gotten the phone calls from taxpayers, usually older folks, who have paid their taxes on time for decades and, for some reason, missed either the first or second half ONCE in their lives only to find out that the penalties and interest can be substantial for anyone, much less someone on a fixed income. No matter how well you explain why it is, we are left pointing to the Suffolk County Tax Act, and the resident is left feeling like they've been robbed at a time when many of them just can't afford it.

This bill would direct the Treasurer's office to create an email notification system whereby interested taxpayers can request, via email or possibly even a web-based sign-up application, that their name and email address be placed on a list for advance email notification/reminder of an upcoming tax due date. Language in the bill was drafted carefully to make it clear that this will in no way absolve the taxpayer of responsibility, so let's say for some reason an email doesn't go through for whatever reason, the taxpayer cannot claim that their failure to pay was a result of anything the County did or didn't do.

There should be little, if any cost associated with this program, but it may save our taxpayers, many of whom are older or have illnesses themselves or whose family members have been ill, from being liable for exorbitant interest and penalties as a result of a simple mistake and the inflexibility of the Suffolk County Tax Act.

Your co-sponsorship would be welcomed but and your support would be appreciated.

Good afternoon Legislator D'Amaro,

As of today, the following 2 agencies which are on the Budget and Finance Committee's Agenda for Tuesday, September 30<sup>th</sup>, are still on the Comptroller Office's noncompliant list:

1. Shinnecock Nation Cultural Center and Museum - Administrative Percentage is **23.72%** (IR 1433)
2. South Fork Natural History Museum - Administrative Percentage is **23.18%** (IR 1434)

I have not heard anything from the Shinnecock Nation Cultural Center and Museum over the last couple of months. In addition, this Agency still has not complied with the requirements of Section 189-66 of Local Law 18-2013 as it has not submitted their Contract Agency Disclosure Forms, financial statements and salary schedules. The deadline for this submission was September 15<sup>th</sup>. As such, no payments will be released to this Agency.

I spoke with Frank Quevedo from the South Fork Natural History Museum earlier today and informed him that his Agency's administrative percentage is now 23% based on the Museum's 2013 audited financial statements. This Agency has complied with the requirements of Section 189-66 of Local Law 18-2013 and has submitted their Contract Agency Disclosure Form, financial statements and salary schedules.




