**CHAIRMAN KENNEDY:**

Okay. The next resolution we have before is IR 1923. I'm going to turn to our Vice-Chair Legislator Browning for the purposes of reading the motion.

**LEG. BROWNING:**

**IR 1923, Adopting Local Law No. -2010, A Local Law to increase public confidence in government by amending the nepotism provisions of the Suffolk County Code. (Co. Exec.)**
