

**HOME RULE MESSAGE REQUESTING NEW YORK STATE
LEGISLATURE TO AMEND THE GENERAL MUNICIPAL LAW,
IN RELATION TO THE REGULATION OF TAXICABS AND
LIMOUSINES IN SUFFOLK COUNTY (SENATE BILL S.6366
AND ASSEMBLY BILL A.8268)**

WHEREAS, legislation has been introduced in the New York State Legislature that would permit the County of Suffolk to adopt local laws regulating the registration of taxicabs, limousines and livery vehicles; and

WHEREAS, the registration of livery businesses allows municipalities to hold owners and drivers of taxis and limousines to certain standards; and

WHEREAS, the registration of livery businesses will protect County residents from operators who may not provide safe, reliable transportation; and

WHEREAS, in order to obtain reciprocity agreements with neighboring counties, the County of Suffolk needs to establish a Taxi and Limousine Commission, which first requires authorizing legislation from the State of New York; now, therefore be it

1st RESOLVED, that this Legislature hereby requests enactment of New York State Senate Bill S.6366 and New York State Assembly Bill A.8268, which would authorize Suffolk County to regulate and register taxicabs, limousines and livery vehicles; and be it further

2nd RESOLVED, that the Clerk of this Legislature is hereby directed to forward copies of this Resolution to Governor Andrew M. Cuomo; to the Majority Leader of the New York State Senate Dean Skelos; to the Speaker of the New York State Assembly Sheldon Silver; to the Minority Leaders of the New York State Senate and the New York State Assembly; and to each member of the Long Island delegation to the New York State Legislature.
