**REHABILITATION OF VARIOUS BRIDGES  
TOWNS OF BABYLON, BROOKHAVEN, EAST HAMPTON AND SHELTER ISLAND  
CAPITAL PROJECT NO. 5850**

The work consists of the following:

Rehabilitation of four bridges (three over water); painting of steel over active roadways; concrete crack and spall repair over water; milling/replacement of roadway asphalt; concrete deck and bridge railing repair; replacement of fencing. Work over water may be performed from platforms or small boats. Installation of silt fences or hay bales where required.

This bid bond will be held as a guarantee that in the event the bid is accepted and contract awarded to the Bidder, the contract will be duly executed and properly secured. **E-MAILED BIDS WILL BE CONSIDERED UNRESPONSIVE.**
