1487-2014	507-2014	32-2014	A Charter Law to consolidate financial management functions in the County Department of Audit and Control. (Lindsay) On the November ballot this year. The functions merge on January 1, 2018. The position of Treasurer is abolished as of midnight on Dec. 31, 2017. The Civil Service law classifications also switch on January 1, 2018. Files must be transferred to Audit and Control by December 31, 2017. There is a detailed outline in Section 3 of the bill.
