

**RESOLUTION NO. 313 -2012, DECLARING AS SURPLUS
AND DIRECTING STUDY TO DETERMINE FUTURE USE OF
CERTAIN CATCH BASIN INSERTS**

WHEREAS, the County of Suffolk recently purchased and installed over 200 catch basin inserts and filters on County roadways to perform preliminary filtering of stormwater runoff; and

WHEREAS, subsequent to the installation of these inserts and the coordinating disposable filters, flooding occurred on the roadways where inserts were installed; and

WHEREAS, the County investigated the increased flooding and determined that the Department of Public Works ("DPW") had insufficient manpower to maintain all of the catch basin inserts and filters with sufficient regularity to prevent flooding. As a result, all catch basin inserts and filters were removed from County roadways; and

WHEREAS, the catch basin inserts are in good condition and may be useful for other municipalities that maintain fewer catch basins than the County; and

WHEREAS, the County should declare these catch basin inserts as surplus to the County's needs and determine if they can be sold or transferred to other municipalities; now, therefore be it

1st RESOLVED, that the 202 catch basin inserts purchased by the Department of Public Works to filter stormwater runoff are hereby declared surplus to the County's needs; and be it further


2nd RESOLVED, that DPW is hereby authorized, empowered and directed to determine if the catch basin inserts can be sold or transferred to other municipalities within the County; and be it further

3rd RESOLVED, that DPW is further directed to provide its findings and recommendations for transfer of the catch basin inserts in a written report to the County Executive and each member of the County Legislature within sixty (60) days of the effective date of this resolution; and be it further

4th RESOLVED, that this Legislature, being the State Environmental Quality Review Act (SEQRA) lead agency, hereby finds and determines that this resolution constitutes a Type II action pursuant to Section 617.5(c)(20), (21) and (27) of Title 6 of the NEW YORK CODE OF RULES AND REGULATIONS (6 NYCRR) and within the meaning of Section 8-0109(2) of the NEW YORK ENVIRONMENTAL CONSERVATION LAW as a promulgation of regulations, rules, policies, procedures, and legislative decisions in connection with continuing agency administration, management and information collection, and the Suffolk County Council on Environmental Quality (CEQ) is hereby directed to circulate any appropriate SEQRA notices of determination of non-applicability or non-significance in accordance with this resolution.
