

**RESOLUTION NO. 838 -2012, NAMING A PORTION
OF NICOLLS ROAD (CR 97) IN SETAUKET IN HONOR OF
LIEUTENANT JOSEPH P. DiBERNARDO**

WHEREAS, Joseph P. DiBernardo was a Lieutenant in the New York City Fire Department; and

WHEREAS, prior to joining the New York City Fire Department, Lt. DiBernardo served as a volunteer in the Setauket Fire Department; and

WHEREAS, Lt. DiBernardo was a technical rescue instructor, providing instruction to members of the Setauket Fire Department and was a founding member of the Brookhaven Technical Rescue Task Force; and

WHEREAS, Lt. DiBernardo was critically injured when Rescue 3, in the Bronx, responded to an apartment building fire on January 23, 2005, which later became known as the "Black Sunday" fire; and

WHEREAS, Lt. DiBernardo put his own life on the line to save a brother firefighter during this incident, and then fell four stories, breaking every bone in his lower body; these severe injuries led to his early passing on November 22, 2011; and

WHEREAS, Suffolk County wishes to honor Lt. DiBernardo's extraordinary sacrifice and his dedication to his family, career and community; now, therefore be it

1st RESOLVED, the portion of Nicolls Road from Route 347 to Fox Hunt Lane in Setauket, shall be named "Lt. Joseph P. DiBernardo Memorial Road"; and be it further


2nd RESOLVED, that the Suffolk County Department of Public Works is hereby authorized, empowered, and directed, pursuant to Section 8-2(W) of the SUFFOLK COUNTY CHARTER, to take all actions necessary and appropriate to effectuate this naming and dedication; and be it further

3rd RESOLVED, that this Legislature, being the State Environmental Quality Review Act (SEQRA) lead agency, hereby finds and determines that this resolution constitutes a Type II action pursuant to Section 617.5(c)(20), (21) and (27) of Title 6 of the NEW YORK CODE OF RULES AND REGULATIONS (6 NYCRR) and within the meaning of Section 8-0109(2) of the NEW YORK ENVIRONMENTAL CONSERVATION LAW as a promulgation of regulations, rules, policies, procedures, and legislative decisions in connection with continuing agency administration, management and information collection, and the Suffolk County Council on Environmental Quality (CEQ) is hereby directed to circulate any appropriate SEQRA notices of determination of non-applicability or non-significance in accordance with this resolution.
